## **Trip Cost: \$2095**

- **Trip cost includes** airfare and ground transportation, in-country meals, lodging, ministry training, leadership, ministry supplies, and adventure day
- **Trip cost does NOT include** immunizations, covid tests or related expenses, travel insurance, and souvenirs

## **Fundraising Due Dates**

- Due w/Application- submit \$95 non-refundable deposit
- October 28<sup>th</sup> - \$1000 raised (\$1095 total)
- December 2<sup>nd</sup> – \$1000 more raised (100% due)

## **Forms Due Dates**

- October 28<sup>th</sup> - Submit Notarized Consent Form to Real Impact Missions  
*(Mail original Notarized Form to RIM at PO Box 1532, Gainesville, GA 30503)*

## **Immunizations Needed**

- Up-to-date childhood immunizations
- Up-to-date Tetanus (required, no exceptions)
- Hepatitis-A
- Typhoid (recommended)

## **Travel Documents**

- Government issued ID (i.e., Valid Driver's License **OR** Passport with 6 months validity).  
College ID will not be accepted
- If you are not a US citizen, or your passport is from a country other than the United States, please make sure you have the proper traveling documents, extra Covid requirements, and/or visas to enter Puerto Rico

## **Covid 19**

- Negative Covid test (PCR Molecular taken within 72 hours of the trip) **OR** Vaccine Card required to be uploaded to Puerto Rico's online portal and brought with you on the trip
- At this point, a negative Covid test is not required to return back to the US due to Puerto Rico being a US Territory
